GOVERNOR SIGNS EXECUTIVE ORDER TO REDUCE GUN VIOLENCE

Governor Tom Wolf was joined by Pennsylvania Commission on Crime and Delinquency (PCCD) Chairman Charles Ramsey; Pennsylvania Emergency Management Agency (PEMA) Director Randy Padfield; Pennsylvania State Police (PSP) Commissioner Colonel Robert Evanchick; Dr. Rachel Levine, secretary of the Department of Health (DOH); Teresa Miller, secretary of the Department of Human Services; Representatives Michael Zabel (D-Delaware), Movita Johnson-Harrell (D-Philadelphia), Tim Briggs (D-Montgomery), Jordan Harris (D-Philadelphia), Joanna McClinton (D-Philadelphia), Patty Kim (D-Dauphin), Maureen Madden (D-Monroe), and Dan Frankel (D-Allegheny); Senators Jay Costa (D-Allegheny) and Anthony Williams (D-Philadelphia); and gun safety advocates this morning as he signed an executive order to strengthen gun violence reduction efforts.

Gov. Wolf stated that hours before the first press conference was scheduled to occur, a gunman in Philadelphia shot six police officers and held two others hostage. He commented that on the same day, a 20-year-old was shot and killed in South Philadelphia. He asserted that gun violence is “too much of a part of our communities.”

Gov. Wolf explained that the suspect who shot police officers in Philadelphia had enough weapons and ammunition to “keep dozens of Philadelphia officers at bay for hours.” He said, “Too many Pennsylvanians have died from gun violence...Too many live every day in fear of being shot...We need to protect all of our lives everywhere in Pennsylvania.” He commented on the need to increase the “weak” gun laws in Pennsylvania. He asserted that the executive order signed today is not an impulsive decision and is the result of his administration working with partners to find “tangible” solutions that focus on reducing gun violence. Gov. Wolf stated that the Second Amendment does not “supersede the inalienable right we all have to life, liberty and the pursuit of happiness.”

Gov. Wolf announced that Ramsey would be the new special advisor charged with leading gun violence reforms. Gov. Wolf explained that the executive order would also establish the new Office of Gun Violence Prevention within PCCD and the Division of Violence Prevention within DOH. He added that the two new offices would combine efforts to curb gun violence from gun safety and public health perspectives.

Gov. Wolf explained that these new offices would address three key areas. He stated that reduction of community gun violence would be addressed by increasing data sharing between police departments, bolstering evidence-based juvenile justice programs, expanding gun buyback programs, directing police to develop training on community gun violence prevention, and expanding positive behavioral intervention supports to improve school safety.

Gov. Wolf indicated that a second key area focuses on the prevention of mass shootings by holding more active shooter training and using prevention tactics to put a focus on domestic terrorism, enrolling Pennsylvania in the “States for Gun Safety” coalition, expanding the See Something, Send Something program, and directing the US Office of Homeland Security to launch an awareness campaign on safety planning and preparedness.



Gov. Wolf spoke about the third key area of stopping domestic violence and suicides with directing the Suicide Prevention Task Force to make recommendations on steps to reduce suicide by guns, building on current mental health stigma campaigns to provide families with resources, developing a multidisciplinary Suicide Death Review Team to increase data collection and inform prevention efforts, and increasing awareness of and strengthening services within the Student Assistance Program.

Gov. Wolf stated that his executive order also establishes the Special Council on Gun Violence, comprised of representatives from PCCD's advisory committees, members of the General Assembly, and various cabinet secretaries. He asserted that this council would establish a Violence Data Dashboard similar to the Opioid Data Dashboard. He commented that all the actions of the executive order would "strike a balance between freedom and safety."

Gov. Wolf also asked the General Assembly to assist his efforts by enacting legislation to mandate reporting of lost or stolen guns, pursue safe storage legislation, continue the push for the swift passage of extreme risk protection orders, and continue to push for universal background checks on all gun purchases. He said, "We want a good Pennsylvania for everybody; one that recognizes the rights embedded in the Second Amendment, but also one that recognizes all of our right to live free of fear."

Ramsey expressed his honor to serve and focus on the "vital and important issue of dealing with gun violence." He explained that while the issue of mass shootings is often what gets national attention, the reality is that "mass shootings take place every day on the streets." He commented that more people died by suicide than by every other means and stated that he was an active member of law enforcement for 47 years. He said, "Something has to be done to reduce gun violence, whether it is by criminals, accidental, suicide, or whatever it is." He thanked the governor for his efforts at the state level and commented that Pennsylvania could be a model for the rest of the US.

Sen. Williams thanked Sen. Costa for allowing him to circulate a letter to the governor on behalf of the Democratic Caucus. He also thanked the governor, whom he said "has done something that no other elected official in the country has ever done...to recognize that the dignity of human beings is most important."

Sen. Williams spoke about how elected officials met yesterday in Philadelphia to discuss changes in gun laws. He commented about acting on behalf of a "very scared public." He asserted that on average, "there is a human being murdered every day by a gun across Pennsylvania." He said, "We have allowed our perspective on an inanimate object [gun] to be the focus of our attention."

Sen. Williams asserted that he wants the people in his neighborhood to understand that the governor has heard them, is responding, and is putting one of the "most experienced people in charge." He said, "It is my hope and my prayer to one day stand at a microphone before I retire to say that we have done effective work to reduce gun violence."

Sen. Costa thanked Sen. Williams for his commitment and applauded the governor for the executive order. He commented on the essential nature of the executive order and thanked Ramsey for "stepping forward." He discussed how Pittsburgh experiences gun violence, which happens "every day and throughout" Pennsylvania and the US. He stressed the importance of investing in community mental health.

Sen. Costa spoke about continuing to "fight on the Senate floor to complement the work of the governor." He called upon his colleagues to help move gun legislation forward. When discussing the executive order, he said, "It's going to be a model for the rest of the country."

Rep. Harris thanked Gov. Wolf for his work on the executive order. He thanked the governor for previously walking with him in Southwest Philadelphia and meeting with those impacted by the gun violence there.

Rep. Harris commented how "gun violence is one of the most prevalent issues in our country." He stated that the homicide rate has increased by four percent in Philadelphia, with 6,902 people shot in the first seven months of this year. He described numerous shooting incidents in Philadelphia.



Rep. Harris remarked on the recent police standoff in Philadelphia. He said, “We stand with those men and women, but just 24 hours later, there were five people shot only two miles away from that incident.” He commented on the value of all life and asserted that legislators “cannot abdicate responsibility” if they do not get passage on all desired gun legislation.

Rep. Harris spoke about how in Philadelphia a three-year-old was shot and killed on her porch while her mother was braiding her hair. He said, “We have to do something to address the pain and carnage that far too many of our citizens feel.”

Rep. Frankel commented on the importance of the issue of gun violence. He thanked his colleagues and singled out the newest member of the Democratic Caucus, Rep. Johnson-Harrell, co-chair of the PA Safe Caucus, for her work on gun safety. He asserted how Rep. Johnson-Harrell has personal experience in dealing with gun violence and its impact on her community.

Rep. Frankel spoke about the mass shooting at the Tree of Life Synagogue in Pittsburgh on October 27, 2018. He said, “When I go to speak to my constituents, the one thing I hear consistently is, ‘What are you going to do about it?’”

Rep. Frankel commended Gov. Wolf for the issuance of the executive order. He commented on how the collaboration between government agencies will assist with curbing gun violence. He opined that controlling gun violence should be a bipartisan issue and stated that rates of gun deaths are the same in rural and urban areas. He asserted that there are approximately two dozen gun control bills in the House which have not yet been addressed with a committee hearing. He said, “We could make background checks to be universal or could allow municipalities to decide what gun laws are right for their communities.

Rep. Frankel spoke about the recent shootings in Dayton, Ohio, with the murder of nine people and injury to 27 others in 60 seconds. He commented on how the devastation caused by the high-powered weapons is a “public health crisis.”

Rep. Frankel discussed legislation that was passed which prevents those who have protection from abuse orders filed against them from possessing firearms. He commented that the bill passed due to the advocacy of groups like Moms Demand Action and CeaseFirePA. He said, “Gov. Tom Wolf took important steps for a safer world...Tomorrow let us carry this inspiration forward and ask the question again: what are we doing to reduce gun violence?”

Gov. Wolf signed the [executive order](#) and took questions from the press.

Are you signing the executive order to put pressure on the General Assembly to enact gun control legislation?

Gov. Wolf responded that he is signing the executive order because of his authority to do so and to coordinate and foster cooperation within his administration. He asserted that although he needs the legislature to act, the executive order addresses the items that he wants. He said, “I am doing this because this is what I can do.” He commented that he still needs the General Assembly to pass legislation.

How much will this cost?

Gov. Wolf opined that he did not think there is a “whole lot of cost.” He asserted that costs would be budgetary through PCCD. He explained that if he learns that there will be additional costs, he will provide that information.

The executive order states that the Special Council on Gun Violence will review the firearms purchase background processes and make suggestions for improvement. What is the goal?

Gov. Wolf responded by saying that in some instances, such as when there are private sales, there is no background check. He commented that Pennsylvania does not have a universal background check and spoke in favor of implementation.

Has the Office of Gun Violence Prevention started having conversations with police departments, and will smaller police departments be included in discussions?

Gov. Wolf responded by commenting on the data-sharing component and how to make information available to local, regional, state, and federal law enforcement to ensure timely and appropriate actions.



Col. Evanchick spoke about conducting additional training for municipal police officers.

Are gun buybacks conducted now?

Col. Evanchick responded that police currently permit gun buybacks but asserted that there is not an actual buyback program.

What will that program look like?

Col. Evanchick stated that he does not know at this time.

What can state police do to monitor hate groups?

Col. Evanchick explained that about 40 different state and federal agencies currently work together daily to do monitoring. He commented on the helpfulness of the See Something, Send Something program and said PSP has analysts who work with troopers.

Will the monitoring be expanded?

Col. Evanchick answered that PSP will look into that.

What do you mean by “data sharing”?

Gov. Wolf responded that data sharing could include sharing posts on social media that might need police follow-up.

Would there be profiling using social media?

Gov. Wolf responded that the issue is not about profiling, but about using information better.

What will be done under the executive order to help prevent suicide?

Sec. Levine responded that she would partner with Sec. Miller on the Suicide Prevention Task Force. She commented on how “violence has many different forms” and asserted that gun violence also involves suicides.

Sen. Williams commented that legislators were present at the event not just about enacting legislation. He said, “We are here because people are scared to death.” He asserted that legislators were present to help provide support for people in their districts. He said, “People are being killed by their neighbors.”

Committee News

House Veterans Affairs and Emergency Preparedness Committee

The committee held a public hearing on House Bill 1568.

[HB 1568 Comitta, Carolyn](#) - (PN 2043) The Pipeline Safety and Communication Board Act establishes the Pipeline Safety and Communication Board to collect and disseminate to the public information of commonwealth agencies relative to the planning, construction, operation, sitting, maintenance, management, inspection and safety of and emergency response procedures for pipelines; and to coordinate communications relating to pipeline activities with federal, state and local government agencies and regulatory authorities, pipelines companies and the public. Effective in 60 days.

Majority Chairman Barrar explained that the legislation would establish a Pipeline Safety and Communications Board. He asserted that he is looking forward to hearing from the entities testifying.

Minority Chairman Sainato explained that he is looking forward to hearing testimony.

Rep. Comitta thanked the chairmen for holding the hearings and thanked Rep. Quinn for being the co- prime sponsor. She



shared background on the need and value of the bill. She explained that Marcellus Shale is now the largest source of natural gas in the U.S. She asserted that there are 11 pipelines which run through her district and stated that these pipelines run through «heavily populated areas.»

Rep. Comitta explained that on almost weekly basis there is information about pipeline incidents somewhere in the United States. She commented on the importance of residents having timely and accurate information about the pipelines. She asserted that the stress around the Mariner East project is a «public health concern.»

Rep. Comitta noted that she realized the limitation of communication which has led to misinformation and that she had offered a solution by proposing the creation of a Pipeline Safety and Communication Board, which would implement and coordinate timely communication regarding pipeline activities in Pennsylvania. She stated that the board would provide information and appropriate safety measures of emergency response procedures for pipelines. Rep. Comitta explained that the board would also be responsible for coordinating communication relating to pipeline issues with federal, state, and local officials. She noted that the board would be composed of state officials from state agencies, the General Assembly, and officials from pipeline companies.

Rep. Comitta asserted that some members of the General Assembly had concerns regarding the Confidentiality Act, or Act 156 of 2012. She stated that there is a lack of consensus on how the act is interpreted. Rep. Comitta noted that the act established a system with a public track and a secure track as they apply to communications.

Rep. Comitta thanked the members of the committee for their consideration of pipeline safety across Pennsylvania.

Rep. Quinn thanked Rep. Comitta for her work on the bill. He noted that this is at least the fifth hearing on pipeline-related issues he has attended. He asserted that his top priority is safety and to ensure that all «residents can live, work, and go to school with safety in mind.» He said that House Bill 1568 oversees oil, gas, and non-gas-related activities. He said, «We cannot afford to simply be reactionary to situations.» He asserted that the importance of welfare of neighbors and children should be at the «forefront.»

[Seth Mendelsohn](#), executive director, Public Utility Commission (PUC), told lawmakers that “the commission currently opposes the legislation unless amended to address the two most serious concerns we will highlight today, including the importance of maintaining Pennsylvania’s Confidential Security Information (CSI) Disclosure Protection Act and clarification of responsibilities and procedures related to Pennsylvania’s Right-to-Know (RTK) Law.” He pointed out the legislation in its current form repeals Pennsylvania’s CSI Act without a plan to replace it. Mendelsohn explained, “CSI is information provided by a public utility that, if disclosed, would compromise security against sabotage or criminal or terrorist acts, and the non-disclosure of which is necessary for the protection of life, safety, public property or public utility facilities.” He testified, “It is important to note that the CSI Act covers not only public utility pipelines, but also electric utilities, natural gas utilities, telecommunication utilities, and water/wastewater utilities.” Mendelsohn encouraged the committee members “to review the CSI Act in its entirety.” He cautioned, “We believe repeal of the CSI Act will result in less protection against public disclosure of CSI and increased risk to the public from persons or entities seeking to harm the commonwealth’s infrastructure.”

Mendelsohn also expressed concerns that “there is a lack of clarity in the act regarding the responsibilities of the board and the commission-or other agencies also subject to the act-when the board receives a RTK Law request.” He noted that section five of the legislation requires the PUC to cooperate in providing information, upon request, to the proposed Pipeline Safety and Communication Board. According to Mendelsohn, “If the board requests information from the commission, there is no provision that allows the commission to decline to release information, nor is there an exemption to refuse dissemination to the board per RTK Law exemptions.” He added, “There is no language in section five to explicitly protect the commission from turning over privileged, confidential, or critical infrastructure information to the board.” Mendelsohn pointed out that “it is unclear whether the board or the commission defends a RTK Law response that is appealed to the Office of Open Records.” He added, “Section five of the act also appears to allow agencies to direct the board to handle RTK Law requests in a manner that does not necessarily require notifying the agency that provided the requested information.”



Mendelsohn went on to outline additional concerns with the proposed legislation. He testified, “Based on the current draft of the act, it is unclear whether the board will attempt to exercise some jurisdiction over interstate pipelines, which generally fall under federal jurisdiction, and if so, under what authority.” Mendelsohn also expressed concern with provisions requiring the PUC chairman to attend quarterly meetings of the board, review information collected for dissemination to the public relating to pipeline activities, and aid in coordinating communications and public and private entities. He pointed out that the legislation does not detail how the proposed board will be funded and staffed. Mendelsohn said the proposed bill is “unclear regarding coordination of communications during emergencies and-if the board is to have a role in this process-how that would interface with the safety-related duties of the PUC, the federal Pipeline and Hazardous Materials Safety Administration (PHMSA), along with local, county and state emergency management agencies and responders.” He also suggested that “there should be greater clarity concerning whether meetings of the board are public meetings, and how they will be noticed/ advertised in order to increase access and transparency.”

Rep. Comitta asked if the PUC sees any concern in the legislation as “intractable.” Mendelsohn responded that at this time, he could not say that there is a specific “deal breaker” with regards to House Bill 1568. He asserted that PUC has concerns and said that they would be happy to work with the committee.

Rep. Comitta commented that there seems to be a need for executive session where people who have a security clearance can have discussions on pertinent issues. She stated that one of the proposed amendments to the bill would be to allow for an executive board that could meet. She asked if an executive component would address the PUC’s concerns. Mendelsohn responded that the PUC could examine the issue of the establishment of an executive board if the bill is amended.

Rep. Quinn asked what suggestions PUC has to improve communications between PUC and the Department of Environmental Protection (DEP) if the current legislation is not the vehicle to address the issue. Mendelsohn recognized that legislatively there are restrictions on the ability to communicate information. He stated that the restrictions that the PUC operates under ensure that they comply with current law.

Rep. Quinn asked the PUC for recommendations on how to move forward to improve communications.

Chairman Barrar explained the necessity of having future stakeholder meetings with his staff, makers of the bill, and the PUC.

Rep. Gabler asked for the PUC’s input on the goal of the legislation and structure proposed. He asked if the concept of the legislation is the most effective way to deal with pipeline safety. Mendelsohn responded that the PUC does not necessarily have a view on that. He explained that they were asked to take a look at the legislation and said that he does not have an opinion as to the “good” or “bad” concept.

Rep. Gabler asked if PUC feels that the legislation would add capabilities in the realm of pipeline safety that the PUC does not already possess. Mendelsohn responded that he is not sure that he can answer that and said that PUC has concerns with some of the issues in the proposed legislation.

Rep. Ryan commented that the bill is a good beginning and asserted his hopes to find a solution to get out information regarding safety to the community as quickly as possible.

Rep. Comitta asked about modernizing Act 156, which Mendelsohn had commented about in his testimony, and whether anyone is currently working on modernizing the act within the PUC. Mendelsohn responded that he did not know. He asserted that the PUC follows the act and makes sure that they are complying with the law.

Rep. Comitta asked if the act prevents important conversations that can improve public safety. Mendelsohn commented that he just attended a program regarding cybersecurity. He asserted that the PUC is willing to working with the legislature to help disseminate information to the public. He stated that there is a balance between protecting security and providing information to the public.



Rep. Comitta commented about the public track and secure track within the Confidentiality Act. She stated that the interpretation of the Confidentiality Act is prohibiting some important conversations between agencies. She asked if one of the goals of modernizing the Confidentiality Act would be to allow for more transparency between agencies. Mendelsohn responded that the act should be looked at in terms of modernization. He asserted that modernization could involve encouraging communications between agencies.

Rep. Comitta asked if there are currently any multi-stakeholder discussions about the “overarching issues” of pipeline safety and public safety, especially regarding natural gas liquids. Paul Metro, manager of the safety division, PUC independent Bureau of Investigation, noted that there is no entity that is looking at communications between different state agencies. He stated that the PUC is facilitating communications between agencies and various government agencies. He stated that the PUC does not have authorization from the legislature to enact an agency-wide communications board.

Rep. Quinn asked if there are any other states that have a similar board that Pennsylvania could model. Metro stated that he is not aware of any.

Chairman Barrar asked if any of the agencies involved in pipelines communicate with one another. Metro commented that he talks with DEP on a daily and weekly basis. He asserted that PUC is careful about discussing CSI. He stated that PUC also speaks with the Pennsylvania Emergency Management Agency (PEMA) on a regular basis.

Chairman Barrar asked whether PEMA could access confidential information from the PUC if requested. Metro responded that they would not necessarily share the information unless it was “vital” to emergency response. Robert Young, deputy chief counsel, PUC, said that Act 156 has a procedure to deal with routine requests for information. He noted that in an emergency, PUC has officers that can go to PEMA for information exchange. He noted that because of the consequences of violating the act, the PUC prefers for the utility to disclose to the agency rather than have the PUC do it. He commented that the penalties of violating the act are criminal penalties and loss of jobs. He stated that the procedures are not set up for emergency sharing. Young asserted that if the proposed legislation had an exception for emergency, that would be helpful.

Rep. Gabler asked what the pipeline safety division provides to Pennsylvania. Metro commented that his agency’s mission is to ensure compliance with federal and state regulations as they pertain to public safety.

Rep. Gabler asked about what an update to Act 156 might look like. Young commented that the areas for change are to allow for communications and said that the specific act does not expressly permit or create a mechanism for sharing to occur. He stated that the Confidentiality Act permits a public utility to designate anything it wants as CSI on filing. He noted that the PUC is then obligated to treat that information as CSI that is protected upon filing.

Rep. Gabler asked who would be the ultimate authority to determine whether something should be classified or not. Young stated that the act “sort of” covers the issue at present and said that it is not triggered upon filing but is triggered upon request. He stated that the filing is typically done through the secretary’s bureau, and asserted those dealing with it are not subject matter experts.

Rep. Gabler asked if there might be an administrative issue with changing this procedure. Young noted that the people currently receiving the requests are not the best qualified to make those decisions.

Rep. Gillen questioned how much interaction PUC has with emergency responders. Metro responded that Federal Pipeline Safety Regulations require training with emergency responders. He asserted the PUC had sponsored trainings recently with emergency responders and said that federal government trainers assist with the training where funding might be an issue.

Rep. Comitta asserted that the goal of House Bill 1568 is to have a “table” for stakeholders to have conversations about pipeline safety, especially with the Mariner East pipeline. She noted that in Chester County there has been communication between various agencies to solve issues relating to the Mariner East pipeline. She stated that a previous conversation about the idea that a cell phone would be prohibited during a gas leak led to agencies learning that a cell phone is not an



ignition source. She asked if there is any current opportunity for multi-agency conversations. Metro stated that PUC believed that Chester County is one of the “elite” counties within Pennsylvania with regards to information sharing. He noted that the PUC later discovered that Chester County school districts and emergency responders were not sharing communications. He noted that through the leadership of Rep. Comitta, stakeholders exchanged ideas about pipeline safety issues.

Rep. Comitta asserted that there may be a need for county-by-county conversations, similar to ones that exist in Chester County. She noted that Pennsylvania needs to have the conversation of what the challenges and opportunities are to make the natural gas industry safer for people who live along the pipelines.

Sarah Boateng, executive deputy secretary, Department of Health (DOH) noted that the mission of DOH is to ensure quality health care for the citizens of Pennsylvania. She asserted that DOH is concerned about the impacts of pipeline activities.

Boateng noted that DOH has created an oil and gas registry. She stated that those who have concerns about the oil and natural gas industry can submit their concerns to DOH by email or phone. Boateng explained that information about submitting the concerns can be found on DOH’s website. She asserted that DOH coordinates with DEP to track and investigate the claims. She noted that the board in the proposed legislation would be another way to communicate.

Boateng asserted that people are more likely to listen to messages from a local source. She explained that DOH works strategically to inform communities about current public health issues and how they can respond. She asserted that the board proposed by legislation would help with the communication efforts. She stated that current DOH messaging efforts are modeled after the Centers for Disease Control and Prevention (CDC) and the World Health Organization using accessibility, actionability, credibility of information, relevancy, and timeliness.

Boateng noted that DOH has a role in reassuring the public by providing information so that it is understandable. She explained that DOH considers how familiar the target agency is with the topic and values the importance of empathy. She stated that DOH plans to bring this strategy to the board to share information with the public in the most effective way.

Boateng affirmed that DOH supports the establishment of the board.

Rep. Comitta noted that communication by the Mariner East pipeline officials has been “terrible.” She stated that people in her district worry about what is happening underground with regards to the pipeline. She asked if DOH has a plan to address that issue. Boateng noted that evidenced-based framework is based upon “timely, transparent, and actionable information-sharing to empower those in crisis.” She said that DOH does that with sister agencies such as PEMA and DEP to be prepared for emergencies. She asserted that transparent information is important to tell the public about what is known and unknown. Boateng explained that DOH is providing communities with action items which can “reduce the feelings of hopelessness.”

Rep. Quinn noted that the idea that a cell phone could cause tragedy has caused stress in the community. He asked if DOH has been involved in trying to put out information regarding the pipeline. Boateng responded that the most specific involvement is the partnership with DEP regarding different environmental and health issues. She stated that DOH works with DEP on a regular basis to “keep lines of communication open and coordinated.”

Rep. Comitta asked how the Confidentiality Act has impacted DOH’s ability to be effective communicators and whether it could impact overall communication if it is modernized. Boateng stated that she has not worked specifically with the Confidentiality Act and said that it is not a “roadblock.” She noted that the confidential information of first responders would be “beyond the purview of DOH.”

Ramez Ziadeh, executive deputy secretary for programs, DEP, explained that DEP regulates pipeline construction as it pertains to erosion and sedimentation (E&S) activities, Chapter 102 of the Pennsylvania Code; water obstructions and encroachments, Chapter 105 of the Pennsylvania Code; and floodplains activities and public utilities, Chapter 106 of the Pennsylvania Code.



He noted that these laws deal with project special conditions which provide for the protection of private water supplies. He asserted that for projects that exceed one of the six DEP regions, DEP posts project information electronically on the DEP pipeline portal. He noted that the pipeline portal can be found on DEP's website.

Ziadeh explained that DEP works closely with county conservation districts to ensure compliance. He noted that DEP inspects projects on a regular basis to ensure compliance with law. He stated that DEP investigates complaints from the public and takes action when violations occur.

Ziadeh noted that DEP "will hold permittees to the highest regulatory standards." He stated that DEP regularly coordinates with state, local, and federal agencies. He commented that DEP communicates with PEMA and PUC to coordinate site inspections, especially in the instance of sinkholes. He explained that regulatory agencies have an obligation to notify DEP of issues that arise.

Ziadeh stated that DEP has been engaged in policy development. He asserted that DEP coordinated two stakeholder groups to discuss horizontal drilling. He noted that the meetings have been completed and asserted that DEP has draft documents in preparation.

Ziadeh stated that for Federal Energy Regulatory Commission (FERC) regulated projects, the process is on the FERC website. He noted that DEP examines how the projects affect waterways but cannot dictate where a pipeline is installed. He asserted that once installed, the transportation of natural gas liquids is outside of DEP's authority. He stated that the PUC oversees and enforces the issues related to transportation of natural gas.

Ziadeh explained that DEP applauds Rep. Comitta's work on House Bill 1568 and supports the concept of increased communication. He noted that creation of the board would facilitate more communication. He asserted that the administration would be supportive of the bill with some amendments, especially as they apply to pipelines. He stated that DEP supports changing the definition of pipelines in the proposed legislation to cover only transmission oil and gas pipelines.

Ziadeh commented that there needs to be greater clarification regarding the type of communication and information sharing. He asserted that there is currently a gap in state law regarding projects that are not subject to FERC jurisdiction as they regulate interstate pipelines. He noted that intrastate pipelines are not subject to FERC requirements.

Ziadeh explained that Gov. Tom Wolf has called for regulation granting citing authority to the PUC. He noted that under the Clean Streams Law, DEP does respond when private waters have been impacted. He stated that DEP can require termination of the activity and restoration and replacement. He noted that DEP does not have the statutory authority to regulate private water wells. He stated that DEP lacks the legal authority to establish and enforce private water well standards.

Ziadeh stated that the Department of Conservation and Natural Resources (DCNR) has a database regarding private water wells. He noted that though the database is incomplete, "it is the best available." He asserted that pipeline companies have been reaching out to private owners of the wells. He stated that DEP will respond and require restoration of private water wells and asserted that there is "a need for a more comprehensive and effective approach for private water well protection."

Rep. Comitta asked what Ziadeh's experience was in working within the Confidentiality Act and how it impacts DEP's ability to communicate with agencies, especially regarding public health and safety issues. Ziadeh responded that DEP is required to make information available regarding permit applications which show routes of projects. He noted that some information is redacted as it applies to personal individual information. He stated that DEP is in constant coordination and communication with PEMA and PUC. He indicated that there is an electronic response system.

Rep. Comitta asked if the current wording of the Confidentiality Act prevents DEP from having conversations about pipeline safety. Ziadeh responded that DEP takes enforcement action within their authority. He asserted that the Confidentiality Act does not impact the work that DEP does involving waterway sources. He also deferred to the PUC.



Rep. Gillen asked if, relative to resources and personnel, DEP has the capacity to cover issues. Ziadeh responded that it is difficult but that DEP needs to prioritize their work. He stated that staff working on permit reviews also conduct complaint investigations. He stated that DEP is “pretty effective,” especially on critical issues.

[Jonathan Fleming](#), acting director, Bureau of Maintenance and Operations, Pennsylvania Department of Transportation (PennDOT), explained to committee members, “Pipelines crossing a state highway are regulated by PennDOT and authorized via a highway occupancy permit similar to the way driveways are regulated and authorized via a highway occupancy permit.” He further explained that the department “regulates the location of the pipeline to ensure the facility is being placed at a location where it minimizes possible interference and impairment to the highway, its structures and highway traffic.” Fleming also told lawmakers, “The construction of the pipeline is regulated to ensure that traffic is not unduly impaired and proper traffic control is in place while under construction for the safety of the traveling public and contractor, as well as to ensure the disturbed highway is restored properly. Without these controls, we jeopardize preserving the safe operation, maintenance, construction and integrity of the highway.”

Fleming pointed out, “Pipelines are the only underground utility for which PennDOT, PEMA, and local emergency management agencies each receive separate information regarding the types of product carried and the depth and location of pipelines running under and parallel to our highway network.” He further explained that pipeline companies are the only utility not required to provide information, mark or locate their infrastructure outside of interstate highway crossings. Fleming also said that with interstate highway crossings, the companies are not required to locate their crossings when the placement of markers is not practical and would not serve the purpose for which the markers are intended. According to Fleming, “This information is not only critical to PennDOT to protect our infrastructure from accidental line strikes, it is also critical for municipal and state officials planning for the safe evacuation of Pennsylvania citizens along our rural and non-interstate highway network during emergency events.”

Fleming expressed support for the legislation, however, he said the department is concerned with “what could be a much wider dissemination of information under the bill.” He also testified that the department would urge the committee to consider points of overlap that might be clarified between the role of the PA One Call Board of Directors and the board created under the legislation. Fleming explained, “The PA One Call Board meets quarterly and has established subcommittees working on specific issues such as compliance, education, mapping and technology, damage prevention, and local government, as well as organizational support committees.”

He continued by saying, “PennDOT believes that it would be helpful to clarify the types of pipelines covered by the bill to avoid overlap with the role of PA One Call, and also to clarify the communication and information sharing that the board would be doing so that we are not duplicating efforts.” Concluding his testimony, Fleming told committee members, “It is in the public interest to regulate the location and construction of utility facilities, and to regulate the location, design, construction, maintenance and drainage of access driveways within state highway right-of-way, for the purpose of security, ensuring the structural integrity of the highway, economy of maintenance, preservation of proper drainage, safe and convenient passage of traffic, and safe and reasonable access. The primary focus is public safety.”

Rep. Comitta noted that the repeal of Act 156 is problematic. She asked if the Confidentiality Act is necessary to protect information and if it could benefit from modernization as outlined by the PUC. Fleming stated that there is always an opportunity to look at past legislation and make it more applicable to today’s activities. He noted that it could benefit from a review.

Rep. Comitta asked if PennDOT’s work would be enhanced by participation in a board of the nature required by House Bill 1568. Fleming noted that PennDOT has a designated space at PEMA for those types of interactions which are “pretty much a daily operation.” Fleming stated that having a direct action with legislation would benefit PennDOT. He noted that the overall issue of transportation as a whole is “incredibly important.”

Chairman Sainato asked about how much of the right of way PennDOT uses for a pipeline. Fleming responded that the right of way varies “right down to the individual property owner.” He asserted that for the most part it is the travelling surface and



three feet past the white line on “most transportation networks.”

Chairman Sainato asked if PennDOT is paid for the right of ways. Fleming responded that there is a fee structure for highway occupancy permits to pay for the review of the permit. He stated that there is more concern about whether proper procedures are followed when replacing pavement. Fleming noted that payment and use of highways depends upon funding of highways, which comes through the Federal Highway Administration (FHWA). Fleming said that FHWA has very specific rules of what can be in the infrastructure of networks. Fleming stated that PennDOT prefers that highways not be used for right of way due to frequent maintenance.

Rep. Gabler asked if, under current law, PennDOT possess CSI and has certain procedures. He also asked how this relates to highway occupancy permits. Fleming said that PennDOT does currently process CSI and has procedures in place to adequately protect it. He asserted that highway occupancy permit issues would need to be referred to chief counsel as it regards to the RTK Law.

Rep. Gabler asked how CSI is used when someone wants to know where to dig. He asked how to balance needs of people needing to know where to dig against the protection of privacy to deter terrorism. Fleming responded that “is a constant struggle.”

Rep. Gabler asked how to modernize current law balancing public policy “imperatives.” He asked Fleming to speak to the need from PennDOT’s perspective as far as information sharing from other agencies. He asked how information sharing currently works and asked if modernization of the current statute could provide for better integration. Fleming noted that from past experiences when there are emergency events, all agencies have some type of communications with PEMA. He stated that because transportation is important, PEMA has a conference room to discuss the issues. He asserted that he has not personally dealt with confidentiality issues on an emergency basis. Regarding current routines, he said that concerns need to be addressed going forward.

Rep. Gabler asked if PennDOT envisions that there is information not currently being shared that would be better shared among agencies. Fleming stated that in planning, having enough information is always better and very beneficial.

Rep. Quinn asked how PennDOT would propose solving the lack of information if the legislation does not proceed, either by making changes to Act 156 or through some other vehicle that PennDOT would propose. Fleming responded that he would need to take some time to think about that. He noted that the proposal of House Bill 1568 is important as “planning partners are huge.” He asserted that ongoing maintenance means that people will be digging frequently.

Rep. Gillen asked if there have been integrity issues regarding highways intersecting with pipeline construction. Fleming responded that PennDOT has not had integrity issues regarding pipeline construction. He asserted that most of those issues are DEP issues. He noted that PennDOT has seen some gasoline pipelines under streams that were compromised and noted that was several years ago.

Rep. Gillen asked if PennDOT had resources to fulfill their mission. Fleming responded that they can always use more people because there are “more potholes than people.” He noted that they would always appreciate more resources.

Chairman Barrar asked if Fleming could forward unanswered information to the committee.

Rep. Comitta thanked testifiers and members of the committee and noted her appreciation to address the importance of public safety regarding natural gas pipelines. She stated that communication in the energy transfer industry has recently improved and expressed her appreciation for that.

Rep. Comitta noted that communication regarding a specific emergency and response system seems to “be moving along really well.” She stated that where the communication is lacking is how emergency response planning is addressed and what new considerations should go into the response planning. She stated that they are not happening at the interagency



level, which is where the bill would provide that requirement.

Rep. Comitta stated that she understands that repealing the Confidentiality Act is “not the best remedy” and that the committee could look into amending it. She referred to Young’s comments from the PUC for Act 156 to make mechanisms for sharing to occur and allow discussion between agencies.

Rep. Comitta stated that the act needs to remove the roadblocks to important conversation. She commented about good suggestions for amendments such as having an executive board that could meet and discuss sensitive information and that would inform the public of safety practices. She noted that another amendment might deal with amending the definition of pipelines.

Rep. Comitta suggested that the committee should take a look at legislative gaps to improve pipeline safety. She asserted that the hearing was “very helpful on many levels to improve the overarching goal to protect public safety along the natural gas liquids pipelines in Pennsylvania.”

Chairman Barrar thanked the testifiers.

Chairman Sainato thanked the testifiers and asserted that everyone wants to make sure that public safety is done properly. He thanked the members for coming to the hearing. He noted that public safety and security are “very critical.”

Rep. Comitta thanked Rep. Quinn for his work on the bill.
